04 - **OBJECTS -**

- A. To encourage the art and sport of Kung Fu and or allied Arts and sports to provide leadership and guidance for the same in India.
- B. To promote, regulate and control the art and sports of Kung Fu and or allied arts and sport in India in accordance with the constitution and bye laws of the Federation.
- C. To provide foster and maintain relations with and between National and International Kung Fu Associations or Organizations or Institutions concerned with objects similar to those mentioned therein.
- D. To hold and/or supervise and/or arrange to hold or supervise competitions, training camps, coaching camps, seminars, demonstrations, and/or sports events etc. of this sports
- E. To participate in various International Sports Championships and Events.
- F. To hold and/or arrange basic coaching camps, advanced coaching camps, foreign coaching camps and examinations for the course of Instructors, Referees and Judges etc.
- G. To publish and/o to arrange to publish books, periodicals, literature, pamphlets and all kinds of printed or allied Arts and Sports.
- H. To arrange or manage the all kinds of District, State or National Kung Fu and all related Championships and such other activities as the Association/may consider desirable.
- I. To affiliate itself with International Organizations but only to the extent to which this Federation remains free and independent in follow of its on constitution and Bye-Laws.
- J. To arrange and/or manage the National and international etc. Kung-fu Championships and such other activities as the Federation may consider desirable.
- K. To do all and such lawful things as are incidental or conductive to the attainment of the above objects or any of them.

**BY-LAWS OF THE
KUNG-FU FEDERATION OF INDIA**

NAME- The name of the Federation shall be "Kung Fu Federation of India." hereinafter referred as 'KFF'
ADDRESS - The registered office of the Federation shall be K-107 Sanjay Gandhi Puram, Faizabad Road Lucknow, Uttar Pradesh India.

05 - Membership

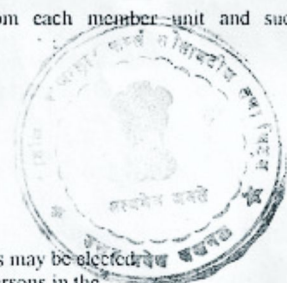
- A- The membership of the Federation shall be open to those who advocate the art and the sport of Kung-fu and or allied arts and sports and fulfill the requirements of the Constitution and Bye-laws of the Federation .
- B. Any Association or sports organization or institution, which has been granted affiliation by the Federation, shall be called as "Member" of the ' KFF'
- C. Those who pay Rs. 15000/- will be life members of the Association and Those who pay Rs. 10000/- will be Patrons those who of the Federation pay Rs. 2000/- will be Members subject to their interest in the sport.

06 - FEE AND REPRESENTATION

- A. The affiliation fee payable by the member unit of the ' KFF' shall be Rs. 2000/- (Rupees Two Thousand RS.Only) per year or as may be decided by the Executive Committee from time to time. Such fee shall be payable within 30 (Thirty) days from the commencement of the financial year.
- B. Those members whose fee are not received by the ' KFF' within three Calendar Months from the due date i.e., commencement of the financial year may cease to be the member of the ' KFF'. However they will have the right to appeal, to the General Body.
- C. The Member who ceases to be member under Paragraph 6 may be readmitted only after the approval of the Executive/General Body.
- D. The memberships will be ceased in case of death, madness, punishment, insolvency and nonpayment of dues.

07 - MANAGEMENT

- A. The management shall consist of two representatives only from each member unit and such representatives shall have the right of one vote each.
- B. The office bearers of the Federation, Executive Committee shall be
 - (i) One President
 - (ii) Six Vice Presidents
 - (iii) One General Secretary
 - (iv) ~~Two~~ Joint Secretaries
 - (v) One Treasurer
- C. Other than the office bearers of the ' KFF' a maximum of eight persons may be elected from among the representatives. The Executive may keep two more persons in the Committee.
- D. The Election of the Office bearers and members of the Executive Committee shall be conducted after four years.



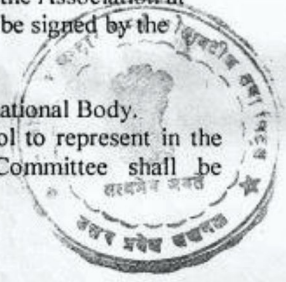

- E. The President and General Secretary can continue on their post for second term if getting 2/3 majority votes.
- F. A meeting of the General Body shall be held within financial year of the Association to adopt and approve the audited accounts of the Federation and review the work done by the executive Committee during a year .The quorum at the general Body meeting shall be 1/3rd of the members of the members of KFI. A notice of 30 Thirty days shall be given to call a meeting of the General body.
- G- The Executive committee shall hold its meetings at least three times during a year . The quorum at such meetings shall be 1/3rd of the members of the Executive Committee.
- H- One third(1/3rd)members of KFI may jointly sent requisition of a general body meeting by sending notice in writing so as to reach registered office of the Federation not latest to them 21 (Twenty one) days before the date of intended meeting stating clearly the purpose for which the meeting is to be called .The general Secretary must call the above maintained meeting immediately and not later then 15 days after the receipt of such requisition by issuing clear 15 days notice in the normal course and clearly specifying the Extraordinary notice of the meeting .
- I- In Emergency the President shall have the power to call emergency Executive Committee meeting by a clear seven days notice and intimate to such notice be sent either telegraphically ,telex or telephonically to members.
- J- The General Secretary shall be the Chief executive officer of the Federation and shall have the power of the Executive Committee in the absence and subject to approval of the same in the Executive Committee meeting.
- K- The members desirous of their candidature for the election to the Executive committee shall send nomination in writing so as to reach registered office of the Association at least 15 days before the Elections, such nominations shall have to be signed by the president and General Secretary of the Member Unit.
- L. The President and Secretary shall represent the ' KFI' to the International Body. However in their absence or for any reason beyond their control to represent in the International body a member chosen by the Executive Committee shall be representative.



08 - **DUTIES AND POWERS OF GENERAL BODY**

- A. To adopt and approve the audited accounts, Reports of the ' KFI' and future program.
- B. To decide the overall general policy of the management . Administration and financial aspect of the association accordingly to which the Executive Committee shall function
- C. To hold Election of office bearers which due and or make in the Executive Committee as it deems fit.

(3) GENERAL SECRETARY:

The General Secretary shall be responsible for carrying out the decision of Federation the executive committee and various sub-committees and carry on the general business of the Federation of including minutes of the improving and rules of the Association and all exercise control and supervision on all financial matters. To do work for the promotion of the objects of Association . To do work on behalf of the Federation.. He will be Responsible for legal proceeding.

(4) JOINT SECRETARY :

One of the Joint Secretary authorized by the Executive Committee shall act as the General Secretary in the absence of the General Secretary, if the absence is for more than one month. The Joint Sec. Will assists the General Secretary in carrying out the business of the Federation and shall perform such functions as may be entrusted by the executive committee.

5) TREASURERS:

The treasurer will keep the account of income and expenditure of the Federation and will sign jointly with General Secretary to operate the Bank Account. The General Secretary will keep the membership Register meeting, proceeding , Register stock, Register Cash book and the other records of the ' KFI'.

10.2 Amendments in Constitution :


Amendments to the Constitution if the Federation may be made at General Body meeting of the ' KFI', any amendments of / or addition to or abrogation of the Constitution shall be circulated amongst the member / units at least 15 days before the date of General Body Meeting such amendments shall needs majority of members in favor by 2/3 present by voting at meeting

Dissolution of Association and its property :


If / upon the Dissolution of the ' KFI' There shall remain after the satisfaction of all its liabilities , any surplus assists the same shall be distributed after , liquidation of otherwise among the member units for the Federation on the suitable basis .The made of the distribution shall be determined by as 3/4 majority of the members present in person or by proxy extraordinary general meeting called for the specific purpose of dissolution or in default there or by referring the matter to reputed arbitrator's or if no arbitrator can be agreed upon then as decided by him .




13 POWER TO FRAME BY-LAWS

14 INTER PETITION OF RULES :


